

**FIRST AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF
PROTECTIVE COVENANTS FOR
THE HOMESTEAD, UNIT I, A REAL ESTATE SUBDIVISION**

THIS AMENDMENT is made this 27 day of March, 2020.

RECITALS

A. Declarant, Mariposa Associates and Lewis D. Hammer and Florence B. Hammer, recorded that certain Declaration of Protective Covenants for The Homestead, Unit I, A Real Estate Subdivision, on May 21, 1971 at Reception No. 421496 in Book 2262 at Page 307, in the Office of the Clerk and Recorder for Jefferson County, State of Colorado, as amended and restated in its entirety by that certain Amended and Restated Declaration of Protective Covenants for The Homestead, Unit I, A Real Estate Subdivision recorded in the Office of the Clerk and Recorder for Jefferson County, State of Colorado on December 19, 2019 at Reception No. 2019121663 (collectively, the "Original Declaration") subjecting the real estate described therein to the terms and conditions set forth in the Original Declaration;

B. The Original Declaration provides for and allows for this First Amendment to the Amended and Restated Declaration of Protective Covenants for The Homestead, Unit I, A Real Estate Subdivision, (the "Amendment") in Article 21 which provides as follows:

These covenants may be amended, modified or terminated at any time by the recording of an appropriate instrument of amendment or termination executed by persons who own at least two-thirds of the Lots in said Subdivision. For purposes of these covenants, the word "person" shall include corporations, trusts and partnerships, general and limited, as well as natural persons.

C. All Owners are aware of the provisions of the Original Declaration allowing for amendment, by virtue of the record notice of the Original Declaration, by acts and disclosures, newsletters or notices of the Association and by other means.

D. This Amendment has been prepared and determined by the Association and by the Owners that have approved this Amendment to be reasonable and not burdensome.

E. The purpose of this Amendment is to revise leasing restrictions.

F. The undersigned, being the President, executes this amendment on behalf of the undersigned Owners representing at least 2/3rds of the Association votes that have consented and agreed to this Amendment.

G. As amended by this Amendment, this amendment shall become part of and incorporated into the Original Declaration.

NOW THEREFORE,

I. Amendments. The Original Declaration is hereby amended as follows:

(a) **Addition. The following is hereby added to the Original Declaration as Article 17(c):**

(c) LEASING. Any Owner shall have the right to lease or allow occupancy of a Lot upon such terms and conditions as the Owner may deem advisable, subject to the following restrictions:

(i) “Leasing” or “Renting” for the purposes of this Declaration is defined as regular, exclusive occupancy of a Lot by any person other than the Owner; provided, however, for the purposes of this Declaration, leasing shall not include the occupancy of the Lot by the child or parent of an Owner. For the purposes of this Declaration, occupancy by a roommate of an Owner who occupies the Lot as such Owner’s primary residence shall not constitute leasing.

(ii) Short term occupancies and rentals of Lots that are less than thirty (30) days, including but not limited to transient, hotel, bed-and-breakfast or vacation-type rentals, shall be prohibited.

(iii) Leases shall be for or of the entire Lot.

(iv) Notwithstanding the preceding, any reservations for short term stays of less than 30 days existing prior to January 1, 2020 shall be permitted and shall not be deemed to be a violation.

II. No Other Amendments. Except as amended by the terms of this Amendment and previous amendments, the Declaration shall remain in full force and effect.
